

## Consent to Data Processing

I hereby give my consent, in accordance with the applicable legal regulations for the protection of personal data, particularly General Data Protection Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, to the processing of my personal data by **PERFECT NETWORK , INC.** CA 91326, with its registered office at 26565 West Agoura Road Suite 200, Calabasas CA 91302, California, United States of America, California Corporate Number 342051, (hereinafter referred to as the "**Controller**"), and agree that my personal data will be processed for the purposes of my registration and participation in the **MY TREES** programme, [www.mytrees.global](http://www.mytrees.global). The data processed for this purpose includes my e-mail address, name, surname, phone number, sex, residential address, bank details, including the account number.

I agree that the Controller will process my personal data for the purposes as stated above for the duration of my participation in the MY TREES programme, and then until all mutual rights and obligations resulting from this relationship are settled. I hereby state that I have been informed of my rights under the applicable legal regulations, including the right of access to personal data, and the right to rectification of inaccurate or incomplete data.

The Controller does not transfer my personal data to other entities, except the transfer to which I gave my express consent (consent to the processing of personal data for marketing purposes). My personal data can be accessed and processed by other entities that provide services to the Controller as part of conducting its business and are bound to observe the principles and obligations of personal data protection on the basis of an agreement with the Controller.

The data provided by me is confidential and is fully secured against misuse by organisational and technical procedures and measures of the Controller. With respect to the registered office of the Controller, my personal data may be transferred to a third country – to the United States of America. The United States of America provides, pursuant to Article 4 (136) of COMMISSION IMPLEMENTING DECISION (EU) 2016/1250 of 12 July 2016, an adequate level of personal data protection.

My personal data is processed by the Controller manually.

My consent to the processing of personal data is freely and knowingly given informed consent, and is provided for the purposes as stated above.

Upon my request, the Controller must give me confirmation that the processing of my personal data provided is carried out for the specified purpose, and inform me to what third parties my personal data is transferred, and for what retention period the data is stored; if I believe that the Controller processes my personal data unlawfully, I can ask the Controller for explanation and remedy, including, but not limited to, completion, rectification, reduction of the processing or liquidation of my personal data. I am aware that I can raise an objection to the processing of my personal data with the Controller, and lodge a complaint to the supervisory authority.
